This permit is subject to the following conditions:

- 1) No glass bottles or containers are allowed in the park (Ordinance #49771).
- 2) Vehicles are not allowed on park trails, service roads and grassy or unpaved areas in City parks. **Parking of vehicles on grass areas, including loading & unloading is prohibited & violators will be ticketed.**
- 3) Commercial vehicles and/or buses are required to have a bus/commercial truck permit and must be parked in a legal parking space on the street or as designated on their parking permit. Buses may unload passengers on the same side of the street as the picnic ground and must then move to the one of the designated parking areas on their permit to park. Busses impeding/blocking the flow of traffic will be ticketed.
- 4) The sale of food and/or refreshments is prohibited on picnic grounds.
- 5) **Open Fires and Barbecuing are allowed in designated areas only;** i.e., picnic grounds or areas where a special event permit has been obtained and the barbecue site has been approved by the Park Department. All coals and litter must be disposed of appropriately. **Large barbeque grills pulled by trailers must be parked in a legal parking space on the street.**
- 6) The possession of and/or use of alcoholic beverages in City Parks is not allowed except by picnic reservation. The use of intoxicating beverages must be in accordance with all existing laws and ordinances. (Ordinance 61289)
- 7) Picnic grounds must be left in a clean and orderly condition. Refuse must be deposited in waste receptacles. **Any excessive cleanup required by the Park Department will result in the permit holder being billed.**
- 8) Various games and events must be confined to the picnic grounds assigned.
- 9) Generators may be used on picnic grounds where electric is not available, however, noise restrictions will apply.
- 10) **No amplified sound is allowed on the picnic grounds.** All other sound must be at a level so as not to disturb the peace, quiet, comfort, or repose of neighboring inhabitants and/or park users and must conform to ordinance #68130.
- 11) Picnic tables must remain under the rented pavilion. The transfer or moving of picnic tables/benches from assigned picnic grounds is prohibited.
- 12) Once a picnic permit has been issued, there are no rain dates, refunds or changes.
- 13) Reservations are not transferable and may be revoked or changed at any time at the discretion of the Park Director.
- 14) The granting of this permit in no way commits the Department of Parks, Recreation and Forestry, nor any other city agency, to provide electrical or other utility service.
- 15) The permit holder agrees to be responsible for the supervision of the event, the conduct of all person present, and damages which may result to the City's property as a result of this event.
- 16) The permit holder agrees to hold the City of St. Louis and its officers and employees harmless from any injury to property or persons that occurs during this event.
- 17) Display signs and advertising matter of any nature are not allowed.
- 18) Due to liability concerns, environmental issues, health concerns and safety, the Parks Division does not allow pony rides, petting zoos, balloon releases and/or confetti.
